- 1) If the pet is not already altered I agree to have the pet altered by the licensed Veterinarian listed above on the date listed above and have shown a valid receipt for this prepaid surgery.
- 2) I have shown proof of current rabies vaccination and obtained a city tag for licensing of this animal and I agree to get all additional shots/vaccinations required by the city and state regulations for this animal with-in 30 days of reclaiming/adopting this animal.
- 3) I agree to have the pet under my control at all times and contained to my property in a humane and safe enclosure when not on a leash. I agree not to abuse or neglect this animal and I understand that this animal must be adequately housed, fed, watered and protected from extreme weather and receive the minimum standards of veterinary care including keeping rabies vaccinations current and city licensing.
- 4) I understand that if for any reason I cannot keep or properly care for this animal I may surrender it back to Windsor Animal Control without cost where the animal may be humanely euthanized after 5 days if a new Adopter cannot be found. I understand further that all fees and deposits made on this animal will not be refunded upon the surrender of this animal back to the Windsor Animal Control including any veterinary expenses.
- 5) I understand the animal covered by the adoption/reclaim paperwork is as far as can be determined by the Adoptee, in good health and that the Adoptee is not responsible for any medical fees incurred after the adoption/reclaim date.
- 6) I agree to give the Adoptee visitation rights to ensure that the terms of the adoption agreement are being observed.
- 7) I understand that the city enforces Nuisance and At Large Ordinances and repeated pick-up of any animal will result in fines and confiscation of the animal. I understand that the City of Windsor limits addresses within the City Limits to a 3 dogs & 3 cats Maximum and does NOT allow any PIT BULL type dogs.
- 8) I understand that failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, I authorize the Adoptee, Windsor Animal Control/City of Windsor, Missouri to reclaim both possession and ownership of the Adopted/Reclaimed Animal without refund of adoption fees, deposits or any veterinarian expenses incurred to date.
